- 3. USING UNNECESSARY ROUGH TACTICS IN PRACTICE OR GAMES TOWARDS ANOTHER PLAYER, OFFICIAL, OR SPECTATOR.
- 4. SETTING FOOT ON THE FIELD/COURT WITHOUT REASONABLE CAUSE.
- 5. BEING INTOXICATED AT ANY OF OUR FACILITIES.
